A. Eligibility

Candidates must have passed the Bachelor's in Fine Art' / Bachelor's in Design /Bachelor's in Architecture / Bachelor's in Business Administration / Bachelor's in Media Management / Bachelor's in Engineering degree examination in the respective branch from the University or an equivalent examination. The candidate must have passed the bachelor's degree in the respective branch with at least Second-Class division.

B. Admission Process:

Admission to the Contemporary Art Practice course is based solely on the candidate's qualification and performance in the interview. The interview will be conducted by a panel of staff and / or experts appointed by the Dean of the Sir J. J. School of Art.

C. Interview Evaluation:

- The Interview carries a total of 300 marks.
- The Candidate who has secured at least 50 marks each, in Theory exam of 100 marks and Practical of 100 marks, will be eligible to appear for the interview.

- The interview before the panel will carry 50 marks.
- Candidate's portfolio and statement of marks will carry 50 marks (25 marks each, respectively)

 Based on the total of all above which adds to a total out of 300 marks, the final merit list shall be put up.

D. Portfolio submission:

It is mandatory for the candidates to present their entire bachelor's Class / Sessional / Term work portfolio during the interview. Only physical portfolios will be considered.

E. Interview Components:

The specific Components of the interview will be decided by the panel of staff and / or experts conducting the interview. They have the authority to determine the structure and content of the interview.

The decision of the interviewing panel will be final and binding upon the candidates

2. M.F.A. - Art Education

A. Eligibility

Candidates must have passed the Bachelor's in Fine Art / Bachelor's in Applied Art / Bachelor's in Design /Bachelor's in Architecture / Bachelor's in Engineering degree examination in the respective branch from the University or an equivalent examination. The candidate must have passed the bachelor's degree in the respective branch with at least Second Class division.

B. Admission Process:

Admission to the Art Education course is based solely on the candidate's qualification and performance in the interview. The interview will be conducted by a panel of staff and / or experts appointed by the Dean of the Sir J. J. School of Art.

C. Interview Evaluation:

- The Interview varies a total of 300 marks.
- The Candidate who has secured at least 50 marks each in Theory exam of 100 marks and Practical of 100 marks will be eligible to appear for the interview.
- The interview before the panel will carry 50 marks.
- Candidate's portfolio and statement of marks will carry 50 marks (25 marks each, respectively)
- Based on the total of all above which adds to a total out of 300 marks, the final merit list shall be put up.

D. Portfolio submission:

It is mandatory for the candidates to present their entire bachelor's Class / Sessional / Term work portfolio during the interview. Only physical portfolios will be considered.

- The Interview carries a total of 200 marks
- Theory of 50 marks
- Interview of 50 marks
- 100 marks will be based on the grand total of marks obtained in the B.Arch. degree examination in the respective branch
- Out of total 200 marks the final merit list shall be put up

D. Portfolio submission:

It is mandatory for the candidates to present their entire bachelor's Class / Sessional / Term work portfolio during the interview.

- Interview carries 50 marks
- Portfolio Presentation carries 50 marks
- Out of total 300 marks will be the final merit list.

- Out of these, 50 marks (50% of the total) will be based on the grand total of marks obtained in the B.F.A. / B.V.A. degree examination in the respective branch.
- The remaining 50 marks will be allotted based on the candidate's performance in the interview.
- Out of total 100 marks the final merit list shall be put up.

D. Portfolio submission:

It is mandatory for the candidates to present their entire bachelor's Class / Sessional / Term work portfolio during the interview. Only physical portfolios will be considered.

E. Interview Components:

The specific Components of the interview will be decided by the panel of staff and / or experts conducting the interview. They have the sole authority to determine the structure and content of the interview.

The decision of the interviewing panel will be final and binding upon the candidates
